Lutyens' Ecclesiastical Masterpiece

Please Help Us to Preserve Lutyens' Tower



You may recall that the old weathervane blew out during Storm Barney in November 2015

It was irreparably damaged as it fell as you can see here:



As the building is listed Grade 1, St Jude's has had no option but to replace the weathervane and after extensive negotiations with Historic England, St Jude's now has a splendid replacement.

Installing the replacement presents St Jude's with **a unique and once in a lifetime opportunity** as a scaffold represents the only safe way of installing it and **the insurers are paying**.

If you value St Jude's as the iconic centrepiece of the Suburb, please help us carry out the essential repairs to the tower whilst the scaffold is up.

How can you help us?

Please consider sponsoring an area of the brickwork. There are 260 square metres of brickwork to cover at a composite cost of £207 per square metre. St Jude's needs to raise £42,000 and St Jude's will recognise all donations of £200 and over with a plaque in the church unless you wish to remain anonymous. If St Jude's raises more than it needs, St Jude's will put the surplus into the restoration fund for its additional restoration projects currently budgeted at £2.75m.



Why are repairs needed?

The building is over 100 years old and sits as a landmark at the top of the Suburb in its historic centre. The tower and spire gets battered by the prevailing winds and the brickwork is in very poor condition as these recent photos show:



How are the works being funded and what is included?

In negotiations with Historic England, St Jude's has applied for a grant of £46,665. St Jude's is contributing £11,666 from its restoration funds which will fall to £24,000 once the works are complete. The costs totalling £86,400 include:

- > Repointing the brickwork.
- > Repairing stress cracks inside the tower.
- > Installing high-level eyebolts to facilitate maintenance in the future.
- > Architects' fees.
- > Contingencies @ 15% of the total cost.
- > An assumption that St Jude's will not be able to recover the VAT incurred – this is because the current scheme expires in March and has yet to be renewed.
